# 2019 Poster Art Contest (For grades K-5)

## Why participate? Fun education tool that aids in teaching students about the law. Winners receive prizes and awards!

- 1. The Dallas Bar Association's *Law Day Poster Art Contest* is open to only students enrolled in elementary schools (Grades K-5 two entry categories are available: K-2nd, 3rd-5th).
- 2. The artwork must be the student's own interpretation of the Law Day theme FREE SPEECH, FREE PRESS, FREE SOCIETY

"Explain or depict how today's society is impacted by freedom of speech and freedom of the press."

- 3. Limit: Only one entry of original work per student will be accepted.
- 4. Poster art must be a two dimensional drawing, painting or collage. No computer-generated work (i.e. taking photos from internet, copies, etc.) will be eligible. Eligible artwork must be 11 x 17 or smaller.
- 5. The artwork must be accompanied by **"2019 DBA Law Day Contest Entry Form"**. The entry form must be fully completed and signed by the student's parent or guardian.
- 6. By entering, the student gives the Dallas Bar Association (DBA), State Bar of Texas and the Texas Young Lawyers Association the right to reproduce material submitted in any medium without time, use, or territorial limitation as long as it is for non-commercial purposes.
- 7. The DBA, State Bar of Texas and the Texas Young Lawyers Association bear no responsibility for lost or damaged entries.
- 8. Entries will be judged on responsiveness to the theme and creativity. The artwork will be initially judged by members of the DBA Law Day Committee. The contestant advancing to the State level will have his/her artwork judged by the State Bar of Texas. All judges' decisions are final.

#### 2019 Essay Contest (For grades 6-8)

### Why participate? Fun education tool that aids in teaching students about the law. Winners receive prizes and awards!

- 1. The competition is open to students enrolled in middle school.
- 2. Participants must interpret the Law Day theme FREE SPEECH, FREE PRESS, FREE SOCIETY showing <u>critical</u> <u>analysis</u> and <u>historical evidence</u>; therefore, all essays must be responsive to and answer this prompt:

"Explain or depict how today's society is impacted by freedom of speech and freedom of the press."

- 3. Limit: Only **one** entry of **original work** per student will be accepted.
- Format:Typewritten, or clearly printed Double-spaced
   8-1/2" x 11" paper 1" margins
   Maximum number of words per submitted essay: 500
- 5. Include the student's name, grade, the teacher's name, and the school on the cover sheet.
- 6. The essay must be accompanied by **"2019 DBA Law Day Contest Entry Form"**. The entry form must be fully completed and signed by the student's parent or guardian.
- 7. By entering, the student gives the Dallas Bar Association (DBA), State Bar of Texas and the Texas Young Lawyers Association the right to reproduce material submitted in any medium without time, use, or territorial limitation as long as it is for non-commercial purposes.

# 2019 Photography Contest (For grades 6-12)

### Why Participate? Fun Educational Tool that Aids in Teaching Students about the Law. Winners Receive Prizes and Awards!

- 1. The competition is open to students enrolled in middle school and high school.
- The photograph must be the student's own interpretation of the Law Day theme FREE SPEECH, FREE PRESS, FREE SOCIETY reflective of this prompt:

"Explain or depict how today's society is impacted by freedom of speech and freedom of the press."

Students are encouraged to use their imaginations in expressing the Law Day theme.

- 3. **Limit:** Only <u>one entry of original recent work per student</u> will be accepted, not having been published in any medium, and it must be taken after **June 7**, **2018**. *A photo taken from the internet is not acceptable*.
- 4. **Format**: one image or collage, color or black and white photographs are considered; no larger than 8x10, no frame or mount; slides will not be accepted. 2 printed copies or a digital photo provided on CD will be accepted. **NO printouts on paper or a photo of a photo will be accepted.**
- 6. The photo must be accompanied by **"2019 DBA Law Day Contest Entry Form"**. The entry form must be fully completed and signed by the student's parent or guardian.
- 7. By entering, the student gives the Dallas Bar Association (DBA), State Bar of Texas and the Texas Young Lawyers Association the right to reproduce material submitted in any medium without time, use, or territorial limitation as long as it is for non-commercial purposes.

# 2019 Editorial Contest (For grades 9-12)

1. The editorial must be written in response to the following prompt:

"Explain or depict how today's society is impacted by freedom of speech and freedom of the press."

- 3. Limit: Only **one** entry of **original work** per student will be accepted.
- 4. The editorial must be **no longer than 500 words**.
- 5. The editorial must be typewritten and double-spaced.
- 6. The editorial must include a cover page with the following information: name of student, the title of the editorial, name of high school, grade, name of teacher, and city of residence.
- 7. Each page of the editorial submission must include a header with the title and page number only.
- 8. The editorial must show critical analysis and be based on historical evidence.
- 9. The editorial must be accompanied by **"2019 DBA Law Day Contest Entry Form"**. The entry form must be fully completed and signed by the student's parent or guardian.
- 10. By entering, the student gives the Dallas Bar Association (DBA), State Bar of Texas and the Texas Young Lawyers Association the right to reproduce material submitted in any medium without time, use, or territorial limitation as long as it is for non-commercial purposes.
